

FAIRY FEET DANCE CLUB - ENROLMENT TERMS & CONDITIONS

THANK YOU FOR YOUR ENROLMENT AT FAIRY FEET DANCE CLUB. PLEASE READ THE FOLLOWING T&C's CAREFULLY - YOUR SIGNED ACKNOWLEDGEMENT BELOW INDICATES YOUR ACCEPTANCE AND CONSENT TO ADHERE TO THESE POLICIES.

SECURE ACCESS - DOOR CODE

As part of your Membership at Fairy Feet Dance Club - you will be given PIN Code access to the Waiting Room area. It is a strict condition of Enrolment that this PIN Code is not given to anyone who is not an authorised person to bring your child to class.

CLASS ATTIRE

Dance attire is strongly encouraged to ensure adequate movement and comfort during class time. Dance shoes are **COMPULSORY** for all students. For safety reasons, students are not permitted to dance in socks, stockings or "Jiffies". Failure to bring appropriate dance shoes may result in a student not being permitted to participate in class. Dance shoes are **STRICTLY NOT TO BE WORN**

OUTSIDE. All students must change in/out of dance shoes before/after class. Hair is to be worn tied/pulled back neatly off the face.

CLASS SAFETY

For the safety of all children, **running in the Studio or Waiting Room is not permitted at any time** including before / after class time and also applies to siblings. Whilst FFDC takes all reasonable care in the conduct of its dance classes, it accepts no responsibility for injury or loss caused. In the event of a medical emergency and a parent/guardian is not able to be located within the venue or contacted by phone, it reserves the right to seek medical treatment or advice for the child and any costs incurred will be the responsibility of the parent/guardian.

AUDIENCE COURTESY (FOR TODDLER AND PRESCHOOL CLASSES)

x1 Parent/Guardian permitted for the purpose of participating in the Toddler class or observing Preschool class (strictly to remain **quietly seated**). Please be respectful of the class environment and refrain from talking/social chatter with other attendees during class time. Mobile phonecalls to be taken OUTSIDE the classroom. Siblings under 12 mths are to be left in alternate care where possible. If they must attend - they are to remain quietly seated at all times or taken to the Waiting Room if they are unable to do so for the duration of class. Any electronic games or devices are to be set on 'SILENT' or used with headphones. FFDC respectfully reserves the right to ask anyone to wait outside the studio if they are causing a continued distraction or disturbance.

CLASS PARTICIPATION

Only students that are formally enrolled and have their Class Fees paid in FULL are able to participate in class. *Friends/family members that are not enrolled in class are NOT permitted to participate and must remain quietly seated during class time.*

TERM FEES

\$25 Annual Membership Fee is charged upon commencement, then in Term 1 annually thereafter. Term Fees are invoiced in full by TERM and are strictly non-refundable. Invoices are sent to your nominated email address and payment is required in FULL by the due date listed. Late payments incur a \$15 fee and placement in class may be forfeited. If you have more than one child enrolled a 10% Sibling Discount on Term Fees will be applied. Refunds/discounts are not given under any circumstances for missed classes, including those missed due to holiday/travel plans or Government mandated Lockdown or Restrictions* (*classes are provided in an online forum in this instance*).

MISSED CLASSES (FOR TERMS 1, 2 & 3 ONLY)

Please notify PRIOR to class if your child is going to be absent. Subject to availability, students can do a make-up class in another group if they miss a class due to illness or holiday. Students are entitled to up to x2 make-up classes per Term by prior arrangement with the Director on the following conditions: 1) *The Director was notified of your absence prior to the start of class.* 2) *Your Term Fees were paid in FULL by the due date.* Make-up classes do not carry over into a new Term (must be taken within same Term). Make-up classes are not available during Term 4 due to End of Year Performance/Concert preparations for each individual class.

AUTOMATIC RE-ENROLMENT & CANCELLATION NOTICE

Your child's enrolment is automatically rolled over from one Term to the next during the course of the calendar year. Cancellation of Enrolment requires **14 days written notice** (submitted to info@fairyfeetdance.com.au) PRIOR to the start of the new Term. Failure to provide 14 days cancellation notice will result in additional charges being incurred including a \$50 Cancellation Fee.

COMMUNICATION

It is the responsibility of all Parents/Guardians to stay up to date with class information, reminders and changes to policies by reading the monthly Fairy Feet Dance Club Newsletter distributed via email around the middle of every month.

CLUB RESPECT

Fairy Feet Dance Club is a fun but fully inclusive programme. All parents/guardians, children and visitors will show respect for all other students, attendees, teacher/s, class props, instruments and studio facilities at all times.

PHOTOGRAPHY

Any photos/footage containing images of other children may not be shared on your own social media without the written consent of the parent / guardian of the other child. Fairy Feet Dance Club advises that images or footage from class, the End of Year Concert or other FFDC events may potentially be used for promotional or marketing purposes including but not limited to the Fairy Feet Dance Club newsletter, website or social media pages.
